S.A.L.-Veterans Outreach shall have the right to use any Reports submitted by Grantee, or any portion thereof, for any reason.
2. Issue a press release to relevant media outlets announcing the Grant award and promoting the project and its value to the community and region.
3. Termination:
  - a. Grantee's violation of any federal, state or local law or regulation.
  - b. Grantee's breach of any of the terms or conditions of this Agreement or
  - c. any unapproved deviation from the Grant Application that has not been cured within 30 days of written notice of such breach



4. In the event the Agreement is terminated under Section 3 C, S.A.L.-Veterans Outreach reserves the right to require Grantee to refund any or all grant funds awarded to Grantee under this Agreement, and Grantee agrees to refund to SAL Veterans Outreach any or all grant funds awarded under this Agreement.
5. Limitation of Liability.
  - a. In no event shall S.A.L. - Veterans Outreach be liable for any indirect, special, incidental or consequential damages or expenses for any negligence, breach of contract or any other acts arising. Out of or relating to this agreement or the activities covered herein.
6. Negation of Warranties:
  - a. Grantee acknowledges and agrees that S.A.L. - Veterans Outreach makes no warranties or representations as to the availability of funds for the grant, this agreement or any disbursements hereunder, or the results achieved, if any, from S.A.L. - Veterans Outreach efforts under this agreement.
